6. Qualifications

- Those who have completed at least 12 years of secondary school education or an equivalent course.
- Those who have completed secondary education (high school level) that qualifies them for admission to university, etc. in their home country.
- Those who can accommodate the expenses of living in Japan, including school fees, or those who have a financial guarantor who can bear the costs.

- 4 Applicants who can submit a certificate of completion of 150 hours or more of Japanese language study at a Japanese language educational institution at the time of application, and a certificate of passing the Japanese Language Proficiency Test N5 or various Japanese language proficiency tests listed in ‘10. Application Documents’ that are equivalent to the Japanese Language Proficiency Test N5.

Note:

Applications may be declined if special educational support or barrier-free facilities are required. Please also refer to section 14, ‘Barrier-free Access.’

7. Application Documents

Please send the following documents by email. Items 1–3 should be sent as PDF files, and item 4 should be sent as a Word file.

- 1 Japanese Language Proficiency Test (JLPT) N5 or higher certificate of qualification (must have passed at the time of application)
- 2 High school graduation certificate (for students from Nepal, GPA of 2.7 or higher for GRADE XI and XII)
- 3 High school graduation certificate or diploma
- 4 Application form (available for download from the web site)

※ Application form 24. ‘Purpose of studying Japanese’ must be written by the applicant themselves.

If it is determined that the statement is a sample or a copy of someone else’s writing, the application will not be accepted.

Notes and Other Information

- Depending on the content of the ‘Purpose of Studying Japanese’ section of the application form (item 4 above), the application may not be accepted.
- Applications will only be accepted from students who can continue studying Japanese at their current Japanese language school until their arrival in Japan.

8. Application period

Japanese Language 2-Year Course	July 15th to August 15th of the year prior to enrolment
Japanese Language 18-month Course	15 January to 15 February of the year of enrolment

9. Selection of prospective students

Among those selected through document screening, interviews, and academic screening, those who have been issued a Certificate of Eligibility for Residence Status will be accepted as students (prospective students), and an application for issuance of a Certificate of Eligibility for Residence Status will be submitted to the Immigration Bureau.

Re-interview

• Prospective students will undergo a re-interview before enrolment, and if their academic ability has declined, they will return their COE to the Immigration Bureau.

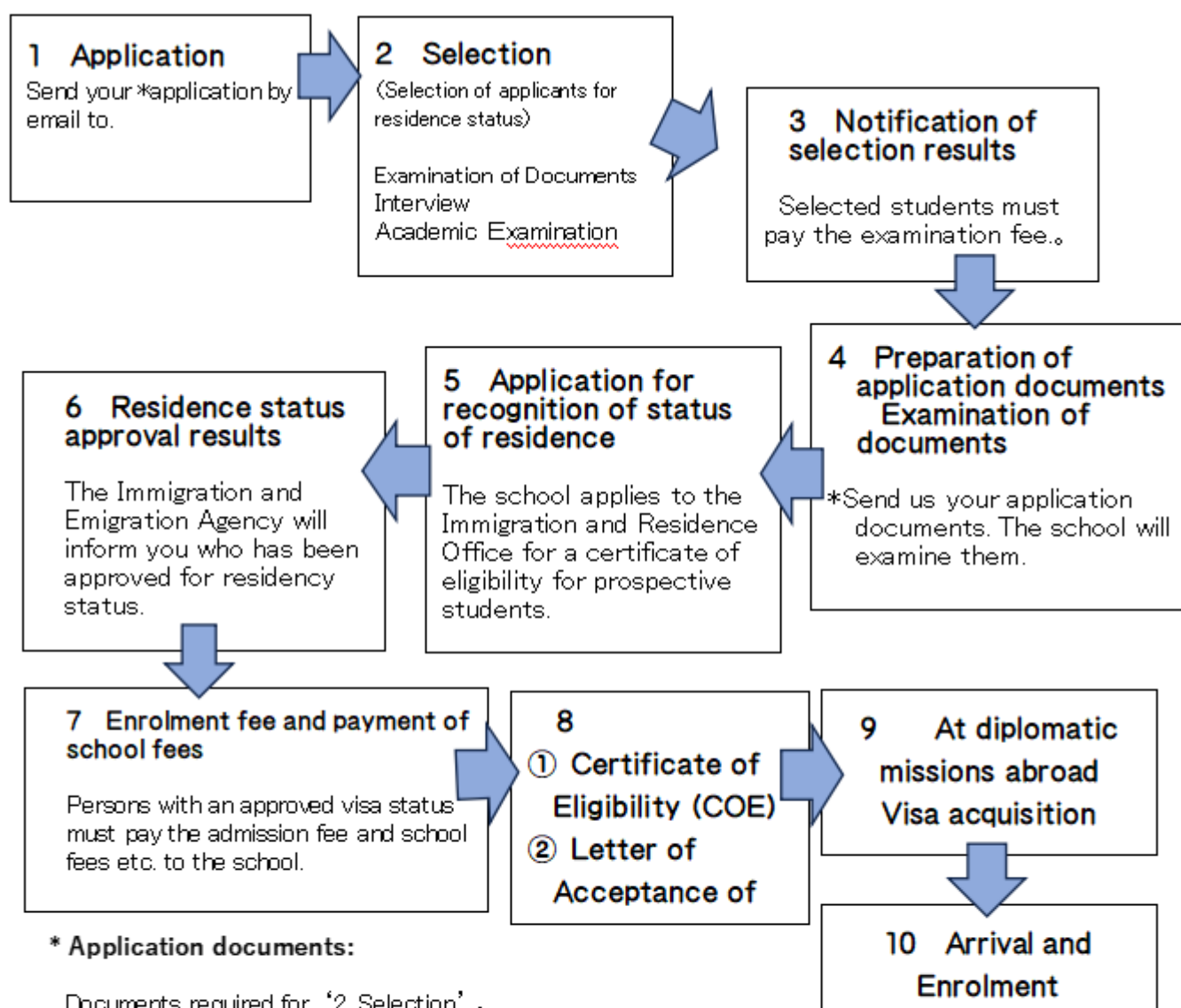
Please refer to the attached ‘List of Application Documents’ for the application documents. The following Japanese language qualifications can be used for the application.

* Application Documents: These are the documents required for the ‘Application for Certificate of Eligibility’ to be submitted to the Immigration Bureau.

1 300 points or higher on the BJT Business Japanese Proficiency Test and JLRT Listening and Reading Comprehension Test (written test) administered by the Japan Kanji Aptitude Testing Foundation
2 Passed the J.TEST : TEST OF PRACTICAL JAPANESE administered by the Japanese Language Proficiency Association/J.TEST Secretariat at the F level or above, or scored 250 points or above on the FG level test.
3 Level 5 (formerly Level 4) or higher on The Japanese Language NAT-TEST administered by Senmon Kyouiku Publishing
4 350 points or higher on the STBJ Standard Business Japanese Test administered by Applied Japanese Language Education Association
5 TOPJ Practical Japanese Language Proficiency Test administered by the TOPJ Practical Japanese Language Proficiency Test Implementation Committee, at the elementary A level or above

6 J-cert Japanese Language Proficiency Test for Daily Life and Work, administered by Japan International Human Capital Development Organisation, at the elementary level or above
7 JLCT Japanese Language Proficiency Test for Foreigners administered by the Japan Language Proficiency Test Organisation, JCT 5 or higher
8 (PJC Bridge) administered by Certify Co., Ltd. C- or higher
9 315 points or higher on the JPT Japanese Language Proficiency Test administered by the Japanese Language Proficiency Test Implementation Committee

12. About School Fee Refund

If a visa is not issued by the Embassy of Japan and the student is unable to enrol despite having received a Certificate of Eligibility and having completed the enrolment procedures by paying the enrolment fee and tuition fees, the enrolment fee and tuition fees, etc. other than the examination fee will be refunded.

Other refunds of school fees, etc. for non-enrolment or withdrawal from enrolment are stated in the ‘Rules for Refund of School Fees, etc. due to Withdrawal from Enrolment’ according to the timing and conditions, and these are published on the website.

In principle, tuition fees, etc. will not be refunded in the case of withdrawal after enrolment.

13. About Personal Information

The Aomori Japanese Language School will only use your personal information to contact you and send you documents and information, and will not use it for any other purposes or provide it to any third party without your consent.

14. Barrier-free accessibility
